STIPULATION

This matter having been scheduled for hearing before the State Office of Administrative Hearings and Rules, on **September 29, 2008**, pursuant to a Formal Complaint, dated **September 5, 2007**, hereafter "Complaint," filed in accordance with the provisions of the Michigan Occupational Code, 1980 PA 299, MCL 339.101 et seq., against COMPLETE BUILDING SOLUTIONS, INC. and RICK D. ROBINSON, Respondents, hereafter "Respondents," by the Department of Labor & Economic Growth, and all parties being desirous of reaching an amicable settlement of said Complaint; therefore

1. **IT IS HEREBY STIPULATED**, by and between the parties hereto, that Respondents admit to the violations set forth in paragraphs 5-9 of the Complaint.

2. **IT IS HEREBY STIPULATED**, by and between the parties hereto, that Respondents committed a violation of Sections 2411(2)(l) and 2411(2)(m) of the Michigan Occupational Code, 1980 PA 299, as amended; MCL 339.2411(2)(l) and 339.2411(2)(m) and 1979 AC, R 338.1551(4) and AACS, R 338.1551(4).

3. **IT IS FURTHER STIPULATED**, by and between the parties hereto, that Respondents' licenses shall be immediately REVOKED. Respondents may not re-apply for licensure until such time as the outstanding judgment in favor of Christine Kirby in the amount of \$36,315.54 is satisfied in full. Respondents' licenses shall be immediately mailed to the

Department of Labor & Economic Growth, Bureau of Commercial Services, P.O. Box 30018, Lansing, Michigan 48909.

4. IT IS FURTHER STIPULATED, by and between the parties hereto, that failure to comply with the terms set forth in this Stipulation shall result in a revocation or continued revocation of all licenses or registrations of Respondents or in the denial of any license or registration renewal and the denial of future applications for licensure or registration until compliance is made with the terms of this Stipulation.

5. Respondents agree to submit written proof of having complied with each requirement of this Final Order, in a form acceptable to the Department, to the Michigan Department of Labor and Economic Growth, Bureau of Commercial Services, Administrative Services Division, P.O. Box 30018, Lansing, MI 48909.


6. IT IS FURTHER STIPULATED, by and between the parties hereto, that the Director of the Legal Affairs Division of the Bureau of Commercial Services, or designee, must approve this Stipulation before it is submitted to the Board for final approval. Should the Legal Affairs Division Director, or that person's designee, or the Board reject this Stipulation, the Department will schedule a contested case hearing in this matter without prejudice to either party.

7. Respondents understand and intend that by signing this Stipulation, Respondents are waiving the right, pursuant to the Occupational Code, supra, the rules promulgated thereto, and the Administrative Procedures Act, 1969 PA 306, MCL 24.201 et seq., to a hearing before an administrative law judge, at which the Department would be required to prove the charges set forth in the Complaint by presentation of evidence and legal authority and at which Respondents would be entitled to appear with or without an attorney to cross-examine all witnesses presented by the Department and to present such testimony or other evidence or legal authority deemed appropriate as a defense to said charges.
