STIPULATION

This matter having been scheduled for hearing before the Michigan State Office of Administrative Hearings & Rules on May 11, 2009, pursuant to a Formal Administrative Complaint filed November 20, 2008, under the Michigan Occupational Code, Article 24, MCL 339.2401-2412, against Respondent, NOW, THEREFORE :

1) IT IS STIPULATED, that Respondent makes ADMISSION to violation of MCL 339.2411(2)(j), as set forth in paragraph six (6) of the Formal Administrative Complaint, all other allegation(s) DISMISSED, with prejudice :

2) IT IS FURTHER STIPULATED, that Respondent Calvin Richardson shall pay a FINE in the amount of ONE THOUSAND TWO HUNDRED FIFTY (\$1,250.00) DOLLARS, under MCL 339.602, § 602(e), PAYABLE to the State of Michigan within SIXTY (60) DAYS from the mailing date of the Final Order issued by the Michigan State Board of Residential Builders and Maintenance & Alteration Contractors adopting this Stipulation Agreement, a fine amount which is payable by certified check, cashier's check or money order, with Complaint No. 304884 clearly written on the memorandum portion of the certified check, cashier's check or money order, and mailed to the Michigan Department of Energy, Labor & Economic Growth, Bureau of Commercial Services, Final Order Monitoring, P.O. Box 30018, Lansing, Michigan 48909-7518.


3) IT IS FURTHER STIPULATED, that in the event of FAILURE TO COMPLY in full with the terms and conditions as set forth above in this Stipulation Agreement, by non-payment


of the required fine amount, within the sixty (60) day period from the mailing date of the *Final Order*, Respondent's Michigan State Residential Builders License No. 21-01-118127, SHALL BE SUSPENDED until payment-in-full has been made as set forth in paragraphs two (2)-above.

4) IT IS FURTHER STIPULATED, that the Director of the Enforcement Division, or designee, must approve this *Stipulation Agreement* before forwarding to the Michigan State Board of Residential Builders and Maintenance & Alteration Contractors, for FINAL APPROVAL, and should this agreement be rejected by the Enforcement Division Director, designee or the Board, this matter will be scheduled for Formal Administrative Hearing, without prejudice to either party.


5) Respondent Calvin Richardson understands that by acceptance of this agreement, the RIGHT IS WAIVED to a formal hearing before an administrative hearings officer, at which time it would be necessary to prove the charges set forth in the Department's Formal Administrative Complaint by presentation of evidence and legal authority and at which Respondent would be entitled to appear, with or without the benefit of an attorney, to cross-examine all adverse witnesses and to present such testimony, other evidence or legal authority deemed appropriate as a defense to said charges.


