1. The assignment cannot be recorded until this form, or a comparable document, is submitted.
2. Submit one original of this document. Upon filing, the original and a Certificate attesting to the assignment, will be returned to the assignee.

Since this document will be maintained on electronic format, it is important that the filing be legible. Documents with poor black and white contrast, or otherwise illegible, will be rejected.
3. This form is to be used pursuant to Section 6 of Act 242 of 1969 for the purpose of assigning a mark and its registration.
