ORDER

On January 5, 2000, Affinity Network Incorporated, d/b/a QuantumLink Communications, (QuantumLink) filed an application, pursuant to the Michigan Telecommunications Act, MCL 484.2101 et seq., for a license to provide basic local exchange service. On April 11, 2002, the Commission granted the application. On June 5, 2003, QuantumLink indicated its intent to surrender the license.

The Commission FINDS that:

- a. Jurisdiction is pursuant to 1991 PA 179, as amended, MCL 484.2101 et seq.; 1969 PA 306, as amended, MCL 24.201 et seq.; and the Commission's Rules of Practice and Procedure, as amended, 1999 AC, R 460.17101 et seq.
- b. The license granted to QuantumLink should be rescinded.

c. QuantumLink should surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

THEREFORE, IT IS ORDERED that:

A. The license of Affinity Network Incorporated, d/b/a QuantumLink Communications, to provide basic local exchange service is rescinded.

B. Affinity Network Incorporated, d/b/a QuantumLink Communications, shall surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26.
