**ORDER**

On December 27, 1996, KMC Telecom II, Inc., f/k/a KMC Telecom Inc. (KMC Telecom),  
filed an application, pursuant to the Michigan Telecommunications Act, MCL 484.2101 *et seq.*,  
for a license to provide basic local exchange and special access services. On April 4, 1997, KMC  
Telecom received its license.

On November 2, 2005, KMC Telecom filed a letter surrendering the above-referenced license.

The Commission FINDS that:

- a. Jurisdiction is pursuant to 1991 PA 179, as amended, MCL 484.2101 *et seq.*; 1969 PA 306, as amended, MCL 24.201 *et seq.*; and the Commission’s Rules of Practice and Procedure, as amended, 1999 AC, R 460.17101 *et seq.*
- b. The license granted to KMC Telecom should be rescinded.

THEREFORE, IT IS ORDERED that:

A. The license of KMC Telecom II, Inc., f/k/a KMC Telecom Inc., to provide basic local exchange service is rescinded.

B. KMC Telecom II, Inc., f/k/a KMC Telecom Inc., shall surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26.
