ORDER

On September 7, 1999, Comm South Companies, Inc. (Comm South), filed an application,
pursuant to the Michigan Telecommunications Act, MCL 484.2101 *et seq.*, for a license to provide
basic local exchange service. On November 30, 1999, Comm South received its license.

On October 7, 2005, Comm South filed a letter requesting to withdraw its authority to provide
resold residential service and intrastate toll service effective November 10, 2005.

The Commission FINDS that:

a. Jurisdiction is pursuant to 1991 PA 179, as amended, MCL 484.2101 *et seq.*; 1969 PA
306, as amended, MCL 24.201 *et seq.*; and the Commission’s Rules of Practice and Procedure, as
amended, 1999 AC, R 460.17101 *et seq.*

b. The license granted to Comm South should be rescinded.

THEREFORE, IT IS ORDERED that:

A. The license of Comm South Companies, Inc., to provide basic local exchange service is rescinded.

B. Comm South Companies, Inc., shall surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26.
