ORDER

On April 2, 1999, Excel Telecommunications, Inc. (Excel), filed an application, pursuant to the Michigan Telecommunications Act, MCL 484.2101 *et seq.*, for a license to provide basic local exchange service. On June 30, 1999, the Commission granted the application. On June 15, 2006, Excel indicated its intent to surrender the license.

The Commission FINDS that:

- a. Jurisdiction is pursuant to 1991 PA 179, as amended, MCL 484.2101 *et seq.*; 1969 PA 306, as amended, MCL 24.201 *et seq.*; and the Commission's Rules of Practice and Procedure, as amended, 1999 AC, R 460.17101 *et seq.*
- b. The license granted to Excel on June 30, 1999 should be rescinded.

c. Excel should surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

THEREFORE, IT IS ORDERED that:

A. The license of Excel Telecommunications, Inc., to provide basic local exchange service is rescinded.

B. Excel Telecommunications, Inc., shall surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so by the filing of a claim of appeal in the Michigan Court of Appeals within 30 days of the issuance of this order, pursuant to MCL 484.2203(12).
