ORDER

On April 18, 2001, Enkido, Inc., filed an application, pursuant to the Michigan Telecommunications Act, MCL 484.2101 *et seq.*, for a license to provide basic local exchange service. On August 16, 2001, the Commission granted the application. On February 24, 2006, Enkido indicated its intent to surrender the license. Enkido is not currently serving any customers.

The Commission FINDS that:

- a. Jurisdiction is pursuant to 1991 PA 179, as amended, MCL 484.2101 *et seq.*; 1969 PA 306, as amended, MCL 24.201 *et seq.*; and the Commission's Rules of Practice and Procedure, as amended, 1999 AC, R 460.17101 *et seq.*
- b. The license granted to Enkido should be rescinded.

c. Enkido should surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

THEREFORE, IT IS ORDERED that:

A. The license of Enkido, Inc., to provide resold and facilities based basic local exchange service is rescinded.

B. Enkido, Inc., shall surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so by the filing of a claim of appeal in the Michigan Court of Appeals within 30 days of the issuance of this order, pursuant to MCL 484.2203(12).
