OPINION AND ORDER

On June 6, 2006, Comcast Phone of Michigan, LLC (Comcast), filed an application, pursuant to the Michigan Telecommunications Act (MTA), MCL 484.2101 *et seq.*, to expand its license to provide basic local exchange service to include the exchanges on the list attached to this order as Appendix A. Comcast is licensed to provide basic local exchange service in 252 communities throughout Michigan pursuant to the September 12, 1996 order in Case No. U-11090, the December 21, 1998 order in Case No. U-11827, the August 20, 2002 order in Case No. U-13437, and the November 25, 2002 order in Case No. U-13520. On July 25, 2006, Comcast received a temporary license expansion to provide basic local exchange service in the exchanges listed in Appendix A.

Comcast explains that in 2002, its existing authority to provide basic local exchange service was consistent with its cable television service areas. However, because Comcast has now

expanded its cable television service areas to include an additional 230 Michigan communities, it seeks authority to expand the geographic scope of its license to include the contiguous municipalities for which Comcast currently has acquired or expanded its cable television franchises subsequent to its November 2002 license amendment.

On July 14, 2006, Comcast served a notice of opportunity to comment on other local exchange carriers and all county clerk offices. Comments were due by August 4, 2006. No comments were filed with the Commission.

The Commission finds that approval of Comcast's application is in the public interest. The expansion of the license is conditioned on compliance with the anti-slamming procedures adopted in Case No. U-11900, the number portability provisions of the MTA, and the number reclamation process adopted in Case No. U-12703. Further, the expansion of the license is conditioned upon the provision of service to customers in the added exchanges within a reasonable time. Failure to comply fully with those procedures may result in revocation of the license or other penalties.

The Commission FINDS that:

- a. Jurisdiction is pursuant to 1991 PA 179, as amended, MCL 484.2101 *et seq.*; 1969 PA 306, as amended, MCL 24.201 *et seq.*; and the Commission's Rules of Practice and Procedure, as amended, 1999 AC, R 460.17101 *et seq.*
- b. Amending Comcast's license to provide basic local exchange service to include the exchanges listed on Appendix A attached to this order is in the public interest.

THEREFORE, IT IS ORDERED that:

A. The license of Comcast Phone of Michigan, LLC, to provide basic local exchange service is amended to include all exchanges listed on Appendix A attached to this order.

B. Comcast Phone of Michigan, LLC, shall provide basic local exchange service in accordance with the regulatory requirements specified in the Michigan Telecommunications Act, MCL 484.2101 *et seq.*, including the number portability provisions of Section 358, the anti-slamming procedures adopted in Case No. U-11900, and the number reclamation process adopted in Case No. U-12703.

C. Before commencing basic local exchange service in the areas added to the license by this order, Comcast Phone of Michigan, LLC, shall submit its tariff identifying the additional exchanges in which it will offer service.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so by the filing of a claim of appeal in the Michigan Court of Appeals within 30 days of the issuance of this order, pursuant to MCL 484.2203(12).
