ORDER

On March 30, 1999, William L. Boucheé filed a complaint against Consumers Energy Company. On June 7, 1999, the complainant failed to appear at the hearing and Administrative Law Judge Daniel E. Nickerson, Jr., recommended that the complaint be dismissed without prejudice.

The Commission FINDS that:

a. Jurisdiction is pursuant to 1909 PA 106, as amended, MCL 460.551 et seq.; MSA 22.151 et seq.; 1919 PA 419, as amended, MCL 460.51 et seq.; MSA 22.1 et seq.; 1939 PA 3, as amended, MCL 460.1 et seq.; MSA 22.13(1) et seq.; 1969 PA 306, as amended, MCL 24.201 et seq.; MSA 3.560(101) et seq.; and the Commission's Rules of Practice and Procedure, as amended, 1992 AACS, R 460.17101 et seq.

b. The complaint should be dismissed without prejudice.

THEREFORE, IT IS ORDERED that the complaint filed by William L. Boucheé against Consumers Energy Company is dismissed without prejudice.
