**OPINION AND ORDER**

On February 25, 2002, the Commission issued an order requiring Consumers Energy  
Company, The Detroit Edison Company, and Indiana Michigan Power Company to file assess-  
ments of their ability to meet customers' expected electric requirements in 2002. The utilities filed  
their assessments by March 29, 2002. On April 22, 2002, then Attorney General Jennifer M.  
Granholm filed comments.

Today, the Commission is issuing an order in Case No. U-13695 requiring the utilities to file  
similar assessments for the summer of 2003.

The Commission FINDS that:

- a. Jurisdiction is pursuant to 1909 PA 106, as amended, MCL 460.551 et seq.; 1919 PA 419, as amended, MCL 460.51 et seq.; 1939 PA 3, as amended, MCL 460.1 et seq.; 1969 PA 306, as amended, MCL 24.201 et seq.; and the Commission's Rules of Practice and Procedure, as amended, 1992 AACCS, R 460.17101 et seq.
- b. The 2002 assessments are moot.

THEREFORE, IT IS ORDERED that this docket is closed.

The Commission reserves jurisdiction and may issue further orders as necessary.
