ORDER CLOSING DOCKET

On January 30, 2007, the Commission issued an order in Case Nos. U-15183, U-15184, and U-15185 accepting the Commission Staff's investigation and report regarding the state of compliance by Michigan utilities with Section 1252 of the Energy Policy Act of 2005, Public Law 109-58, which sets forth standards for time-based rate schedules. The order adopted the report's finding that six of the eight Michigan electric utilities that are subject to Section 1252 currently offer time-based rate schedules and directed further proceedings for the other two utilities to be conducted in Case Nos. U-15184 and U-15185. Because proceedings in Case No. U-15183 are now complete, the docket should be closed.

The Commission FINDS that:

- a.
