**ORDER REQUESTING COMMENTS**

On June 5, 2000, 2000 PA 141 (Act 141) took effect. Section 10r(6) of Act 141 required the Commission to establish a Michigan Renewable Energy Program (MREP). By order dated April 17, 2001 in Case No. U-12915, the Commission commenced a proceeding to establish the MREP. Among other things, the Commission Staff (Staff) was directed to submit periodic reports to the Commission regarding renewable energy production and consumption in Michigan and the progress of the MREP (the MREP reports).

On October 1, 2007, the 2006 MREP Data Report, the 2006 Annual MREP Report, and the MREP Net Metering Program Report for the year ended June 30, 2006 were submitted to the

Commission. These reports have been placed on the Commission's website,<sup>1</sup> and the Commission finds that this docket should be opened to receive public comments regarding the reports. All comments relating to these reports shall be filed in this docket by January 4, 2008.

The Commission has selected this case for participation in its Electronic Filings Program. Written and electronic comments may be filed with the Commission and must be received no later than 5:00 p.m. on January 4, 2008. Written comments should be sent to:
