**NOTICE OF INTERVENTION
OF THE MICHIGAN PUBLIC SERVICE COMMISSION**

Pursuant to Rule 214 of the Rules of Practice and Procedure of the Federal Energy Regulatory Commission (“Commission”), 18 C.F.R. § 385.214 (2009) the Michigan Public Service Commission (“MPSC”) hereby submits its Notice of Intervention in the above captioned proceeding.

I. DESCRIPTION OF THE FILING

In an order issued on November 19, 2009¹, the Commission found that, based upon its review of publicly available information on file with the Commission, Great Lakes Gas Transmission Limited Partnership (“Great Lakes”) may be substantially over-recovering its cost of service, causing Great Lakes’s existing rates to be unjust and unreasonable. The Commission therefore initiated an investigation, pursuant to Section 5 of the Natural Gas Act, to determine whether the rates currently charged by Great Lakes are just and reasonable and set the matter for hearing. The order also directed Great Lakes to file a full cost and revenue study with the Commission.

II. NOTICE OF INTERVENTION

The MPSC is an agency of the State of Michigan created by 1939 Pub. Acts 3, Mich. Comp. Laws Ann. § 460.1 *et seq.* As the Michigan regulatory agency having jurisdiction and authority to control and regulate rates, charges, and conditions of service for the retail sale of

natural gas and electricity in the State, the MPSC is a “state commission” as defined in 16 U.S.C. § 796(15) and 18 C.F.R. § 1.101(k) (2008).
