**ORDER**

On February 11, 2002, Tonya Renay Wells (Citizens Action Committee) filed a complaint against Michigan Consolidated Gas Company over a billing dispute. On September 24, 2003, the complainant filed a request to withdraw the complaint.

The Commission FINDS that:

- a. Jurisdiction is pursuant to 1909 PA 300, as amended, MCL 462.2 et seq.; 1919 PA 419, as amended, MCL 460.51 et seq.; 1939 PA 3, as amended, MCL 460.1 et seq.; 1969 PA 306, as amended, MCL 24.201 et seq.; and the Commission's Rules of Practice and Procedure, as amended, 1999 AC, R 460.17101 et seq.
- b. The complaint should be dismissed.

THEREFORE, IT IS ORDERED that the complaint of Tonya Renay Wells (Citizens Action Committee) against Michigan Consolidated Gas Company is dismissed with prejudice.

The Commission reserves jurisdiction and may issue further orders as necessary.
