ORDER

On January 9, 2003, Pio Marzolo filed a complaint against Michigan Consolidated Gas Company. On September 29, 2003, the complainant requested that the complaint be withdrawn.

The Commission FINDS that:

- a. Jurisdiction is pursuant to 1909 PA 300, as amended, MCL 462.2 et seq.; 1919 PA 419, as amended, MCL 460.51 et seq.; 1939 PA 3, as amended, MCL 460.1 et seq.; 1969 PA 306, as amended, MCL 24.201 et seq.; and the Commission's Rules of Practice and Procedure, as amended, 1999 AC, R 460.17101 et seq.
- b. The complaint should be dismissed.

THEREFORE, IT IS ORDERED that the complaint of Pio Marzolo against Michigan Consolidated Gas Company is dismissed with prejudice.
