OPINION AND ORDER

On December 26, 2002, Quicksilver Resources, Inc., (Quicksilver) filed an application, pursuant to the provisions of 1929 PA 9, as amended, MCL 483.101 et seq., requesting authority to construct and operate the Half Moon pipeline in Otsego County, Michigan.

On June 16, 2003, Quicksilver requested that its application be held in abeyance for two weeks.

On September 2, 2003, Quicksilver requested permission to withdraw its application.

The Commission FINDS that:

a. Jurisdiction is pursuant to 1929 PA 9, as amended, MCL 483.101 et seq.; 1919 PA 419, as amended, MCL 460.51 et seq.; 1939 PA 3, as amended, MCL 460.1 et seq.; 1969 PA 165, as amended, MCL 483.151 et seq.; 1969 PA 306, as amended, MCL 24.201 et seq.; and the Commission's Rules of Practice and Procedure, as amended, 1999 AC, R 460.17101 et seq.

b. Quicksilver's request for permission to withdraw its application to construct and operate the Half Moon pipeline should be granted.

THEREFORE, IT IS ORDERED that Quicksilver Resource, Inc.'s request for permission to withdraw its application to construct and operate the Half Moon pipeline in Otsego County, Michigan is granted.

The Commission reserves jurisdiction and may issue further orders as necessary.
