ORDER VACATING PRIOR ORDER

On May 10, 2006, the Commission granted a February 17, 2006 application filed by 3M's Express Inc. (3M's), for authority to change its name to 3+1 Express Inc. (3+1). Approval of the application was contingent upon compliance with all Commission requirements, rules, and regulations.

On August 22, 2006, the Commission issued an order in this matter dismissing the application of 3M's for authority to change its name to 3+1 predicated on information that the applicants had failed to comply with the Commission's regulations. Subsequently, it was discovered that the applicants' compliance submission had been received, but was misidentified. Therefore, the Commission finds that the August 22, 2006 order dismissing their application should be vacated and that an order should be issued approving the request by 3M's for authority to change its name to 3+1.

The Commission FINDS that:

- a. Jurisdiction is pursuant to 1933 PA 254, as amended, MCL 475.1 *et seq.*; 1939 PA 3, as amended, MCL 460.1 *et seq.*; 1969 PA 306, as amended, MCL 24.201 *et seq.*; and the Commission's Rules of Practice and Procedure, as amended, 1999 AC, R 460.17101 *et seq.*
- b. The August 22, 2006 order dismissing the application filed by 3M's and 3+1 should be vacated.
- c. 3M's application for authority to change its name to 3+1 should be approved.

THEREFORE, IT IS ORDERED that:

- A. The August 22, 2006 order dismissing the application filed by 3M's Express Inc., for authority to change its name to 3+1 Express Inc., is vacated.
- B. 3M's Express Inc.'s application for authority to change its name to 3+1 Express Inc., is approved.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26.
