UPDATED IMPORTANT INSURANCE INFORMATION

Effective immediately, carriers holding MPSC Michigan Intrastate Authority that transport new, used or disabled vehicles are defined as a hazardous material carrier pursuant to the Federal Motor Carrier Safety Administration's 49 Code of Federal Regulations (CFR) section 172.101 & 49 CFR 171.8. The carrier is subject to the minimum \$1,000,000 Public Liability and Property Damage insurance requirement for hazardous material carriers regardless of the number of vehicles transported.

This change in regulations impacts your insurance limits only.

You are **not** required to obtain a Hazmat endorsement on your license unless you are transporting a load which meets placarding requirements. Placarding requirements are found in Section 172.500 of the FMCSA HM regulations. The website is <http://www.fmcsa.dot.gov/rules-regulations/rules-regulations.htm>

INTRASTATE USDOT NUMBERING PROGRAM

As of June 1, 2009, the Motor Carrier Division of the Michigan Public Service Commission began issuing USDOT numbers for intrastate motor carriers with vehicles over 10,000 GVW. This function was previously performed by the Michigan State Police.

The phone number to call is 1-888-464-8736. The hours of operation are Monday – Friday 8:30 am – 12:00 noon and 1:00 pm – 4:30 pm.

Display of USDOT numbers is required by State law. There is no charge for applying for USDOT numbers.

2010 UNIFIED CARRIER REGISTRATION (UCR) DELAYED

The Federal Motor Carrier Safety Administration (FMCSA) published a notice of proposed rulemaking to establish the annual Unified Carrier Registration Agreement (UCRA) fees for the 2010 UCR registration year.

Until these fees are set by FMCSA, there will be a delay in the 2010 UCR process. You will be notified as soon as the 2010 UCR is to commence.

DISPLAYING USDOT NUMBER ON COMMERCIAL MOTOR VEHICLE

In accordance with Federal Motor Carrier Safety Regulations (FMCSR § 390.21(c)(1)), the display of a USDOT number on a commercial motor vehicle must "appear on both sides of the self-propelled CMV". Contrary to a recent newspaper publication, there is no new requirement to display this number "on the WINDOW of the vehicle as part of the Interstate Motor Carrier Identification Program." This was verified by Lieutenant Charles Black of the Michigan State Police, Traffic Safety Division.
