**NOTICE OF HEARING
FOR THE MICHIGAN GAS CUSTOMERS OF
NORTHERN STATES POWER COMPANY, A WISCONSIN CORPORATION,
AND WHOLLY OWNED SUBSIDIARY OF XCEL ENERGY, INC.
CASE NO. U-16150**

- Northern States Power Company, a Wisconsin Corporation, and wholly owned subsidiary of Xcel Energy, Inc., plans to use a gas cost recovery factor of \$0.64270 per therm to compute its Michigan gas customers' bills for the 12-month period ending March 2011, if the Michigan Public Service Commission approves its request.
- The information below describes how a person may participate in this case.

This hearing will be a prehearing conference to set future hearing dates and decide other procedural matters.

PARTICIPATION: Any interested person may attend and participate. The hearing site is accessible, including handicapped parking. Persons needing any accommodation to participate should contact the Commission's Executive Secretary at (517) 241-6160 in advance to request mobility, visual, hearing or other assistance.

The Michigan Public Service Commission (Commission) will hold a hearing to consider the December 28, 2009 application of Northern States Power Company, a Wisconsin Corporation, and wholly owned subsidiary of Xcel Energy, Inc. (NSP-W) to implement a gas cost recovery plan and gas cost recovery (GCR) factor of \$0.64270 per therm to compute bills for its Michigan gas customers for the billing months of April 2010 through March 2011. NSP-W also seeks approval to use an updated contingency mechanism and include in the calculation of the commodity cost of gas, gains and/or losses on certain financial instruments used for hedging gas commodity costs.

All documents filed in this case shall be submitted electronically through the Commission's E-Dockets Website at: michigan.gov/mpscedockets. Requirements and instructions for filing can be found in the User Manual on the E-Dockets help page. Documents may also be submitted, in Word or PDF format, as an attachment to an email sent to mpscedockets@michigan.gov. Any person wishing to intervene and become a party to the case shall electronically file a petition to intervene with this Commission by February 16, 2010. (Interested persons may elect to file using the traditional paper format.) The proof of service shall indicate service upon NSP-W's attorney, Kelly M. Martorano, Miller, Canfield, Paddock and Stone, P.L.C., One Michigan Avenue, Suite 900, Lansing, Michigan 48933.

Any person wishing to make a statement of position without becoming a party to the case, may participate by filing an appearance. To file an appearance, the individual must attend the hearing and advise the presiding administrative law judge of his or her wish to make a statement of position. All information submitted to the Commission in this matter will become public information: available on the Michigan Public Service Commission's Web site, and subject to disclosure.

Requests for adjournment must be made pursuant to the Commission's Rules of Practice and Procedure R 460.17315 and R 460.17335. Requests for further information on adjournment should be directed to (517) 241-6060.
